- Y. Technical capabilities.
- ^r. Corporate capabilities and human resources.

A real estate developer becomes qualified to practice after attaining the required score as follows:

Size of Collective Real Estate Investment Scheme	Establishment Capital according to the Commercial Register	Required Qualification Score
Small (capital less than fifty million riyals)	1, riyals or more	٤ • points or more
Medium (capital between fifty million and three hundred million riyals)	•••,••• riyals or more	•• points or more
